

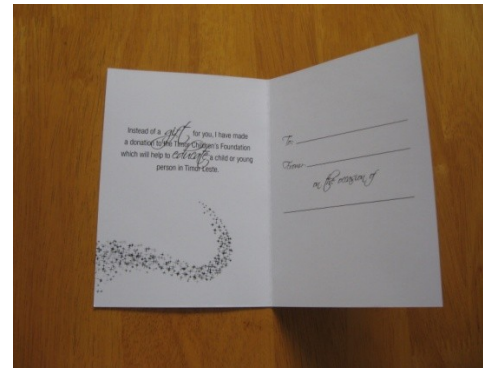
TIMOR CHILDREN'S FOUNDATION
